

Official Rules

Starting on October 1, 2019, Dana-Farber Cancer Institute and the Jimmy Fund (“DFCI”) will invite companies and schools (grades K-12 and colleges/universities) via email, Facebook (<http://www.facebook.com/TheJimmyFund>), Twitter (<https://twitter.com/TheJimmyFund>), the Program website (<http://www.rallyagainstcancer.org/>), and other methods to register a team in the 2020 Rally Against Cancer program (together, the “Participating Teams”). The Team Coach of each Participating Team who chooses to respond to the invitation must: (i) visit the URL reflected in the invitation, (ii) supply all requested information in a complete and accurate fashion to DFCI, and (iii) submit a contribution of ten dollars (\$10) or more (online via <http://www.RallyAgainstCancer.org>, or offline via a check made payable to DFCI mailed to 10 Brookline Place West, 6th Floor, Brookline, Massachusetts 02445) on or before April 16, 2020 at 5:00pm ET to be eligible for a chance to win any of the prizes as described below. Registration will be available to Participating Teams in the following divisions:

WORKPLACE DIVISIONS

- Division 1: Fewer than 100 employees
- Division 2: 101-250 employees
- Division 3: 251-500 employees
- Division 4: 501 or more employees

SCHOOL DIVISIONS

- Division 1: Fewer than 100 students
- Division 2: 101-250 students
- Division 3: 251-500 students
- Division 4: 501 or more students

The winners will be determined at DFCI: 10 Brookline Place West, 6th Floor, Brookline, Massachusetts, on April 16, 2020 at 05:01pm ET. The Senior Vice President for Philanthropy, or their designee, shall be responsible for drawing at random the name of one (1) potential winner.

The potential winners will be notified by phone, mail and/or email. If a potential winner cannot be reached after ten (10) days from the first notification attempt, or if a participant is found to be ineligible, or if the notification is returned or undeliverable, or if a participant declines “winner” status, that participant will forfeit all rights as the winner, and an alternate winner will be selected. In the event the alternate winner declines the prize, the prize may be designated for another DFCI fundraising event at DFCI’s sole discretion. Prizes will be shipped via a traceable method of delivery.

In order to be eligible to participate in the contests, a Participating Team Coach must, as of the date of entry: (i) be eighteen (18) years of age or older, and (ii) be a legal resident of one of the fifty (50) United States or the District of Columbia. Directors, officers and employees of DFCI, and persons otherwise affiliated with DFCI, are not eligible to win the prize; this includes immediate family members of any of the aforementioned groups. The term “immediate family” includes spouses, siblings, parents, children, grandparents, and grandchildren, whether as “in-laws,” or by current or past marriage(s), remarriage(s), adoption, co-habitation or other family.

The top workplace and school with the most dollars raised on or before April 16, 2020 at 5:00pm ET will each receive a visit from one (1) Red Sox player at the workplace or school location of the winning Participating Team. Winning Participating Teams located within thirty (30) miles of the Metro-Boston area are eligible for a chance to win this prize. Participating Teams located further than thirty (30) miles of the Metro-Boston area are eligible to participate in the Program but are not eligible to receive the Red Sox player visit as a prize. The identity of the Red Sox player will be announced at a later date and time to be determined by DFCI. The date of the Red Sox player visit will be mutually agreed upon by DFCI, the Boston Red Sox player, the winning Participating Team, and the workplace or school location. This

prize has a fair market value of five hundred dollars (\$500).

Further, the Participating Team from each Division with the most dollars raised on or before April 16, 2020 at 5:00pm ET will receive two (2) tickets to a 2020 Boston Red Sox home game at Fenway Park in Boston, Massachusetts, with seats located in the right field grandstand. The date of the game will be announced at a later date and time to be determined by DFCl. This prize has a combined fair market value of one hundred and four dollars (\$104) and will be awarded to the Team Coach of each winning team.

The top workplace with the most dollars raised on or before April 16, 2020 at 5:00pm ET that does not win a visit from a Boston Red Sox player, will receive three (3) Fielding Packages at the 2020 John Hancock Fantasy Day on May 30, 2020 at Fenway Park in Boston, Massachusetts. Each Fielding Package has a fair market value of seven hundred fifty dollars (\$750) and includes the following for one (1) person: thirty (30) minutes of on-field fielding practice, breakfast or lunch, John Hancock Fenway Fantasy Day t-shirt, Jimmy Fund hat, exclusive access to the Boston Red Sox dugout including a professional photograph of the participant and grandstand admission for up to ten (10) guests (food and dugout access is limited to the on-field participant only). The Fielding Package will be awarded to the Team Coach of the winning team.

The top school with the most dollars raised on or before April 16, 2020 at 5:00pm ET that does not win a visit from a Boston Red Sox player will receive a visit from the World Series Trophy. This prize has a fair market value of five hundred dollars (\$500).

Participating Team Coaches in any Division will receive one (1) limited edition Boston Red Sox/Jimmy Fund hat upon registration. This prize has a fair market value of twenty-five dollars (\$25). Further, Participating Teams across all Divisions who raise and submit to DFCl one thousand dollars (\$1,000) or more on or before April 16, 2020 at 5:00pm ET will each receive thirty-six (36) Jimmy Fund hats, while supplies last. This prize has a fair market value of twenty-five (\$25) per hat and will be awarded to the Team Coach of each qualifying team.

The first twenty-five (25) Participating Teams in any Division to raise and submit to DFCl three thousand dollars (\$3,000) on or before April 16, 2020 at 5:00pm ET will each receive two (2) tickets to a 2020 Boston Red Sox home game at Fenway Park in Boston, Massachusetts, with seats located in the right field grandstand. The date of the game will be announced at a later date and time to be determined by DFCl. This prize has a combined fair market value of one hundred and four dollars (\$104) and will be awarded to the Team Coach of each winning team.

Participating Teams in any Division who raise and submit to DFCl five thousand dollars (\$5,000) on or before April 16, 2020 at 5:00pm ET will be entered into a drawing to win a visit from one (1) Red Sox player at the workplace or school location of the winning Participating Team. The identity of the Red Sox player will be announced at a later date and time to be determined by DFCl. The date of the Red Sox player visit will be mutually agreed upon by DFCl, the Boston Red Sox player, the winning Participating Team, and the workplace or school location. Winning Participating Teams located within thirty (30) miles of the Metro-Boston area are eligible for a chance to win this prize. Participating Teams located further than thirty (30) miles of the Metro- Boston area are eligible to participate in the Program but are not eligible to receive the Red Sox player visit as a prize. This prize has a fair market value of five hundred dollars (\$500).

Participating Teams in any Division to raise and submit to DFCl ten thousand dollars (\$10,000) on or before April 16, 2020 at 5:00pm ET will be entered into a drawing to win a visit from the Boston Red Sox mascot, Wally the Green Monster, at the workplace or school location of the winning Participating Team. The date of the Boston Red Sox mascot visit will be mutually agreed upon by DFCl, the Boston Red Sox mascot, the winning Participating Team, and the workplace or school location. Winning Participating Teams located within thirty (30) miles of the Fenway Park, 4 Jersey St, Boston, MA 02215, are eligible for a chance to win this prize. Participating Teams located further than thirty (30) miles of Fenway Park are eligible to participate in the Program but are not eligible to receive the Boston Red

Sox mascot visit as a prize. This prize has a fair market value of three hundred and fifty dollars (\$350).

Participating Teams in any Division to raise and submit to DFCI fifteen thousand dollars (\$15,000) on or before April 16, 2020 at 5:00pm ET will be entered into a drawing to win one (1) Fielding Package at the 2020 John Hancock Fantasy Day on May 30, 2020 at Fenway Park in Boston, Massachusetts. Each Fielding Package has a fair market value of seven hundred fifty dollars (\$750) and includes the following for one (1) person: thirty (30) minutes of on-field fielding practice, breakfast or lunch, John Hancock Fenway Fantasy Day t-shirt, Jimmy Fund hat, exclusive access to the Boston Red Sox dugout including a professional photograph of the participant and grandstand admission for up to ten (10) guests (food and dugout access is limited to the on-field participant only). The Fielding Package will be awarded to the Team Coach of each winning team. There will be three (3) participating teams chosen.

Participating Teams in any Division to raise and submit to DFCI twenty thousand dollars (\$20,000) on or before April 16, 2020 at 5:00pm ET will be entered into a drawing to win one (1) Batting Package at the 2020 John Hancock Fantasy Day on May 30, 2020 at Fenway Park in Boston, Massachusetts. Each Batting Package has a fair market value of seven hundred fifty dollars (\$750) and includes the following for one (1) person: thirty (30) minutes of on-field batting practice, breakfast or lunch, John Hancock Fenway Fantasy Day t-shirt, Jimmy Fund hat, exclusive access to the Boston Red Sox dugout including a professional photograph of the participant and grandstand admission for up to ten (10) guests (food and dugout access is limited to the on-field participant only). The Batting Package will be awarded to the Team Coach of the winning team. There will be two (2) participating teams chosen.

NO PURCHASE OR CONTRIBUTION NECESSARY TO ENTER. Maximum of one (1) entry per Participating Team. The odds of winning depend on the number of valid entries received. Please contact the Corporate Partnerships Office at 617-632-5420 to request an "entry form" if you would like to participate in Rally for the Jimmy Fund and its contests without registering a team or contributing to or raising funds for DFCI. All entries must be complete to be eligible. Deadline to enter is April 16, 2020 at 5:00pm ET.

Prizes are non-transferrable, non-refundable, non-negotiable, not redeemable for cash or for re-sale, and no substitution will be allowed. Prizes will not be replaced if lost or stolen. Other restrictions may apply. Should a prize become unavailable to DFCI for any reason, DFCI reserves the right to substitute an item of equal or lesser value. If a prize is date-specific, winners must be available on the date(s) specified. Winners may be required to sign an affidavit of eligibility, a receipt, a Certificate of Intent, and/or a waiver form provided by DFCI, prior to receipt of the prize.

Any valuation of the prizes stated above is based on available information provided to DFCI, and the value of any prize awarded to a winner may be reported for tax purposes as required by law. Winners are solely responsible for reporting and paying any and all applicable taxes related to the prize and for paying any expenses associated with a prize which is not specifically provided for in these Official Rules. Winners may be required to provide DFCI with valid identification and a valid taxpayer identification number or social security number before the prize will be awarded. Any person winning over \$600 in prizes from DFCI may receive an IRS form 1099 shortly following the end of the calendar year and a copy of such form will be filed with the IRS. Any person winning \$5,000 or more in prizes from DFCI may be required to pay the applicable taxes to DFCI before any prize will be awarded, per IRS regulations.

By participating in the contests described above, participants agree to abide by all terms of these Official Rules and all decisions of DFCI, made in its sole discretion, which decisions shall be final. DFCI will interpret these Official Rules and will resolve any disputes, conflicting claims or ambiguities concerning the rules or the drawing, and DFCI's decisions concerning such disputes shall be final.

All participants, their heirs, executors and administrators, waive, release and forever discharge DFCI, all

sponsoring entities, their respective trustees, directors, officers, employees, and agents, from all claims of liability, damages and rights of action of whatever nature or description, in equity or at law, present and future, that may arise out of or relate to participation in the drawing, including the use of any prize.

DFCI is not responsible for lost or stolen prizes, incorrect or inaccurate transcription of entry information, for any human error, technical malfunctions, lost/delayed data transmission, omission, interruption, deletion, defect, theft or destruction or unauthorized access to, or alteration of, entries, for line failures or other failures of any telephone network, server, providers, computer equipment, software or any combination thereof, for inability to access any web site or online service or any other error or malfunction, or for late, lost, illegible, misdirected or incomplete entries which may limit a participant's ability to participate in the drawing. DFCI is not responsible for technical, hardware or software failures of any kind, lost or unavailable network connections or failed, incomplete, garbled or delayed transmissions.

The contests are governed by the laws of the Commonwealth of Massachusetts. By participating in the contests, each participant consents to the exclusive jurisdiction of the courts located in Suffolk County, Massachusetts, for resolution of all disputes.
